Carbon Reduction Targets

To achieve our net zero goal by 2030, we have set the following interim targets:

- **2024:** Reduce Scope 3 Category 6 emissions by 10% through optimised travel policies and increased use of virtual meetings.
- **2026:** Achieve a 25% reduction in Scope 3 emissions by promoting sustainable commuting options and further optimising business travel.
- **2028:** Achieve a 50% reduction in total emissions through comprehensive waste management programs and sustainable practices across our operations.
- **2030:** Achieve net zero emissions across all scopes.

Carbon Reduction Initiatives

Short-Term Initiatives (2023-2024)

- **Travel Policy Review:** Implement policies to minimise non-essential travel and promote virtual meetings.
- **Sustainable Commuting:** Encourage the use of public transport, cycling, and carpooling among employees.



• **Energy Efficiency:** Work with our landlord to obtain and monitor energy usage data, and implement energy-saving measures.

Medium-Term Initiatives (2024-2026)

- **Green Travel:** Partner with travel agencies to offset carbon emissions from business travel.
- **Employee Engagement:** Launch awareness campaigns and training programs to promote sustainable practices among employees.
- Waste Management: Implement a comprehensive waste reduction and recycling program.

Long-Term Initiatives (2026-2030)

- **Renewable Energy:** Explore opportunities to switch to renewable energy sources for our operations.
- Carbon Offsetting: Invest in verified carbon offset projects to neutralise remaining emissions.
- **Sustainability Partnerships:** Collaborate with clients and suppliers to promote sustainability throughout the supply chain.

Supply Chain Engagement

We recognise that our supply chain plays a crucial role in our carbon footprint. To ensure our commitment to net zero extends beyond our immediate operations, we will:

- **Supplier Assessment:** Evaluate and select suppliers based on their environmental performance and commitment to sustainability.
